MANA FELLOWSHIP CENTER, Corporate Identity Number U85300DL2021NPL375938, is responsible for the Television Program Service distributed exclusively via the Internet under the name TV Maná Hindi and takes seriously the privacy and protection of the data provided by its users.

This Privacy Policy governs, together with the General Terms and Conditions of Use, the Television Program Service distributed exclusively via the Internet under the name TV Maná Hindi, hereinafter simply referred to as the Website.

1.PRIVACY AND SECURITY

MANA FELLOWSHIP CENTER is the entity responsible for collecting and processing users' personal data and may, within the scope of its activity, use subcontracted entities or partners to pursue the purposes indicated herein.

MANA FELLOWSHIP CENTER ensures its users privacy and security regarding the data provided, both while browsing the Website and when viewing its content, and only the necessary data is requested and collected, according to explicit indications and the user's choices.

2.COLLECTION OF PERSONAL DATA

Access to this browsing information will be carried out anonymously, making it impossible to uniquely identify the user.

3.USE AND PROCESSING OF COLLECTED DATA

TV Maná Hindi aims to ensure the quality and integrity of the information provided by its users and has implemented the necessary technological and organizational measures to keep the information secure, accurate, up to date, and complete.

In specific and concrete situations, access to certain services or platforms may require the collection of the user's personal data through a form made available on the Website.

In such cases, the personal information collected is used exclusively by TV Maná Hindi and for the purposes expressly indicated in the respective form.

By completing any form available on the Website, the user expressly accepts the processing and inclusion of the data collected for the purposes mentioned in that form.

During the data collection process, and at each point where such data is requested, the user will be informed—either through a hyperlink or through appropriate notices included in the form itself—whether the provision of data is mandatory or optional.
